# Treasurer's Report:

Mr. Joyce reviewed the Treasurer's Report for the month of June. The beginning balance on June 1, 2021 was \$210,830.01. Receipts for the month totaled \$4,979.65 from interest, CBAC, ACIA and a refund. Disbursements for the month totaled \$15,551.01 leaving an operating account balance of \$200,258.65 (accounting for outstanding checks). The account balance in the ACIA loan account was \$8,627.12.

Outstanding balance was reported as \$40,136.27on the ACIA loan.

Bill lists were presented. The bill lists for April of \$12,443.88 and May of \$9,292.04 were presented for ratification as being previously approved by the Executive Committee. The June bill list of \$104,658.17 was presented for approval. The June bill included the prepayment of \$80,000 to the ACIA loan as previously authorized.

Motion to ratify the April and May bills and approve the June bills made by Mr. Ramsay and 2<sup>nd</sup> by Ms. Forosisky. Bills were approved by unanimous voice vote, abstention by Ms. DiLeonardo.

authorizes the District to advertise for proposals, and the District will manage the contract. Approved by unanimous vote.

- 10–21 RESOLUTION AUTHORIZING AGREEMENT WITH THE CUMBERLAND COUNTY IMPROVEMENT AUTHORITY FOR STRATEGIC ECONOMIC DEVELOPMENT PLAN AND COVID RECOVERY AND RESILIENCY PLANNING Moved by Ms. DiLeonardo 2<sup>nd</sup> by Ms. Forosisky; the CCIA has submitted a proposal for a strategy for downtown Millville which will address decline in business from Covid and other factors, funding will depend on current grant funds availability. Approved by unanimous vote.
- 11-21 RESOLUTION AUTHORIZING NO COST ENGAGEMENT WITH SMART GROWTH AMERICA AND CENTER FOR CREATIVE LAND USE FOR TECHNICAL ASSISTANCE Moved by Ms. DiLeonardo 2<sup>nd</sup> by Mr. Ramsay; the USEDA has a program for technical assistance to nuclear communities which provides no cost consulting; the Smart Growth America and CCLR consultants proposed a focused land use study to evaluate commercial and industrial lands in Salem County. Approved by unanimous vote.
